



# EMERGENCY SERVICES CUSTOM PLATES



In New York State, custom plates allow easy identification of vehicles owned by members of emergency services groups. They are subject to the following conditions: **your current registration must be in the name of the emergency services member (except for Volunteer Ambulance Service and Volunteer Fire Fighter - see "note" below); only ONE set of plates may be issued to any one customer (except for Water Rescue Team).**

**PLATE SERIES REQUESTED (required proof and initial fees are identified in parentheses):**


- Civil Air Patrol (PROOF: Valid Civil Air Patrol card – FEE: \$60.00)
- Emergency Medical Technician (PROOF: Copy of Health Department registration certificate – FEE: \$60.00)
- Emergency Medical Technician Paramedic (PROOF: Copy of Health Department Certificate AEMT4 – FEE: \$60.00)
- Ham Radio Operator (PROOF: Copy of FCC License – FEE: \$35.00)

**NOTE:** To obtain custom plates in the two series listed below, the current registration must be in the name of the emergency services member OR his/her spouse.

- Volunteer Ambulance Service (PROOF: Letter from ambulance company certifying eligibility. Must be on ambulance company letterhead. FEE: \$43.75)
- Volunteer Fire Fighter (PROOF: Letter from Fire Chief certifying eligibility. Must be on fire company letterhead. FEE: \$43.75)

- Water Rescue Team (PROOF: Copy of an official document that proves you are an active member of a Water Rescue Team – FEE: \$53.75, PERSONALIZED FEE: \$85.00). You may provide up to three choices. Also, you must explain the meaning of your chosen combination in the section below.

**IMPORTANT:** Only the Water Rescue Team plates may be personalized. Do not complete the personalization section below if you have chosen a different plate series.

If the International Symbol of Access  is required, only five spaces are allowed.

**Please do not send cash!** Make check or money order payable to Commissioner of Motor Vehicles. Please allow 4 to 6 weeks for delivery. The annual renewal fee is: \$31.25 for Civil Air Patrol, Emergency Medical Technician and Emergency Medical Technician Paramedic; \$25.00 for Water Rescue Team (\$56.25 for Water Rescue Team personalized plates); \$15.00 for Ambulance Service; and \$6.25 for Ham Operators. There is no annual fee for Volunteer Fire Fighter. These fees are in addition to your vehicle registration renewal fee. You will be billed for the plates every two years when you renew your registration.

- NOTE:**
- Plates are not ordered until we receive **ALL** required documents and fees.
  - The next available number in the series will be assigned. **You cannot choose your own standard plate number.**
  - Falsifying documents will result in cancellation of the custom plates.
  - **Plates will be mailed to the address on the vehicle's registration file. If you have moved and not updated your address on your registration record, please complete the Change of Address form MV-232.**

**IMPORTANT:** Making a false statement in any registration application, or in any proof or statements in connection with it, or deceiving or substituting in connection with this application, is a misdemeanor under Section 392 of the Vehicle and Traffic Law, and may also result in the revocation or suspension of the registration and/or the applicant's license, pursuant to regulations established by the Commissioner. The act of renewing these plates shall constitute your certification that you remain eligible to continue holding these plates.
